Brunelcare's Little Heath Care and Support is a 64-bed care home and 24-bed reablement service in Cadbury Heath, South Gloucestershire. The care home will provide 24/7 nursing with dementia care expertise.

Little Heath Care and Support is Brunelcare's fifth care home. All of our colleagues are subject to a Disclosure and Barring Service (DBS) check before working for us and, once approved, they undergo a full induction programme and receive continuous training.

In addition to our own rigorous self assessment, we are regulated by the CQC. We also regularly seek our customers' views and feedback to ensure we maintain a high standard of care and high levels of satisfaction in our services. Our team is extremely experienced at working with older people who may be frail, have a learning disability, or have a long term illness.



Little Heath Care and Support Activities

Brunelcare Care Homes pride themselves on the activities they offer their residents. Sessions at Little Heath will be a way of bringing residents together and allow the opportunity for socialisation. Little Heath will be hosting activities such as coffee mornings, bingo, arts and crafts, exercise sessions, film nights and music events. These activities may vary depending on what the majority of residents at Little Heath wish to have at their care home.

Little Heath Care and Support has also introduced a town square that replicates a town centre or busy high street. The town square includes an onsite hairdressers, visiting chiropodist and shop where residents can go to purchase toiletries, snacks and other essentials. The town square also hosts a coffee shop where residents, family and friends can meet for a cup of tea and a catch up. The town square allows residents to feel like they're leaving their home without having to leave the building.

Funding your place at Little Heath Care and Support



There are three funding options to look into when applying for a place at Little Heath Care Home:

- Self-funded Care
- 2 Local Authority Funded Care
- 3 Care funded by Health (Continuing Healthcare)

Frequently asked questions

- Who will be providing my care and support?
- A Brunelcare have their own care and support team that are able to help you in creating your own care and support plan, including promoting your participation and involvement in schemes.
- Will you have your own room with your own bath, shower or toilet?
- All the rooms at Little Heath are equipped with an en suite that includes a level access wetroom shower and toilet. We have baths on site for residents to enjoy with hoists for easy access.
- Can people visit Little Heath Care and Support?
- A Of course, it's your home. We welcome visitors to Little Heath. Contact the Care Home Manager for more information.
- O How does the home deal with complaints?
- A We have a formal complaints or compliments procedure display in the home. You can also find out more information on our website: www.brunelcare.org.uk
- Can you bring your pet with you?
- A This can be discussed with the Care Home Manager.

- Can you choose when you have your meals and is there a choice?
- A Yes, everyone living with us at Little Heath can choose when they have their meals. There is a choice between two meals for lunch and dinner, alongside a vegetarian option and a variety of breakfast options.
- Can you get up and go to bed when you like?
- A Yes. Residents are free to go to bed when they like and get up when they wish.
- Is there a phone you can use to make and receive calls in private?
- A The use of personal mobiles is permitted. We can also offer the use of our cordless phones when needed.
- Q Are there smoking and non-smoking areas?
- A The building is a non-smoking environment, however there is an external smoking area on site.
- Can I visit the Care Homes before I make a decision?
- A Most certainly! Arrangements can also be made to visit by contacting the Care Home Manager.
